GOLF CART PERMIT APPLICATION

A permit may be issued for a golf cart, in Liberty, Indiana, if it is equipped as required by the ordinance adopted by the Liberty Town Council.

A golf cart permit authorizes the operation of a golf cart on highways properly designed by the appropriate city or county as permissible for the operation of golf carts. It is the responsibility of the golf cart owner to know what roads are designated as permissible for the operation of golf carts.

The owner of the golf cart must provide proof of liability insurance at the time of application.

A golf cart must be equipped with headlights, tail lights, turn signals, rear view mirror, seat belts, windshield, a slow-moving vehicle emblem or flashing red or amber light to the rear. Each of these items of equipment must meet the standards for motor vehicles.

An authorized Liberty Police Officer must complete an inspection of the golf cart.

Permits will be issued annually and are valid from January 1st of each year. The fee for a Golf Cart Permit is \$30.00 annually.

Permit/sticker is to be affixed to the lower left side of the windshield in a manner as to be visible from the front of the vehicle.

Sign a Hold Harmless Agreement.
